#### 申請資格 Eligibility Criteria

香港特別行政區(香港特區)多次入境許可證是簽發給在香港特區工作、就讀或居留的台灣華籍居民,目的是為許可證持有人提供 本證件,讓其可在獲批准居港期間的任何時間返回香港及加蓋延長逗留期限的簽注

Hong Kong Special Administrative Region (HKSAR) Multiple Entry Permit may be issued to Chinese residents of Taiwan who have been permitted to take up employment, study or residence in the HKSAR. The HKSAR Multiple Entry Permit is issued for the purposes of providing the holder with a document which allows the holder to re-enter the HKSAR at any time within the period of permitted stay and for extension of stay endorsement.

台灣華籍居民,如符合下列條件,即可申請香港特區多次入境許可證:

Chinese residents of Taiwan may apply for a multiple entry permit for the HKSAR if:

- 獲准在香港特區工作、就讀或居留;
- they have been permitted to remain to take up employment, study or residence in the HKSAR;
- 持有可用以返回台灣的旅行證件,該證件必須在其擬留港期限屆滿後仍有最少兩個月的有效期;及
- they hold a travel document valid for re-entry to Taiwan for at least two months after the expiry of their proposed stay in the HKSAR; and
- (iii)並無持有由台灣當局以外機關簽發的任何旅行證件〔《台灣居民來往大陸通行證》(俗稱「台胞證」)除外〕 they are not in possession of any travel document issued by other authorities outside Taiwan (except "Mainland Travel Permit for Taiwan Residents" (commonly known as "Tai Bao Zheng").



### 收費 Fee

有關申領有效期一年的香港特區多次入境許可證(16 頁)的費用為港幣 390 元,而申領有效期三年的香港特區多次入境許可證(32 頁)的費用則為港幣 780元

The fee for the issue of a HKSAR Multiple Entry Permit valid for one year (16 pages) is HK\$390 and a HKSAR Multiple Entry Permit valid for three years (32 pages) is HK\$780.
